Microwave: For single serving: place nuggets on microwave safe plate and cover with paper towel. Heat on high for 60-65 seconds or until heated thoroughly. For each additional serving, add approximately 40 seconds to heating time. Let stand 1 minute before serving. Cooking times and oven temperatures may vary, adjust accordingly.
